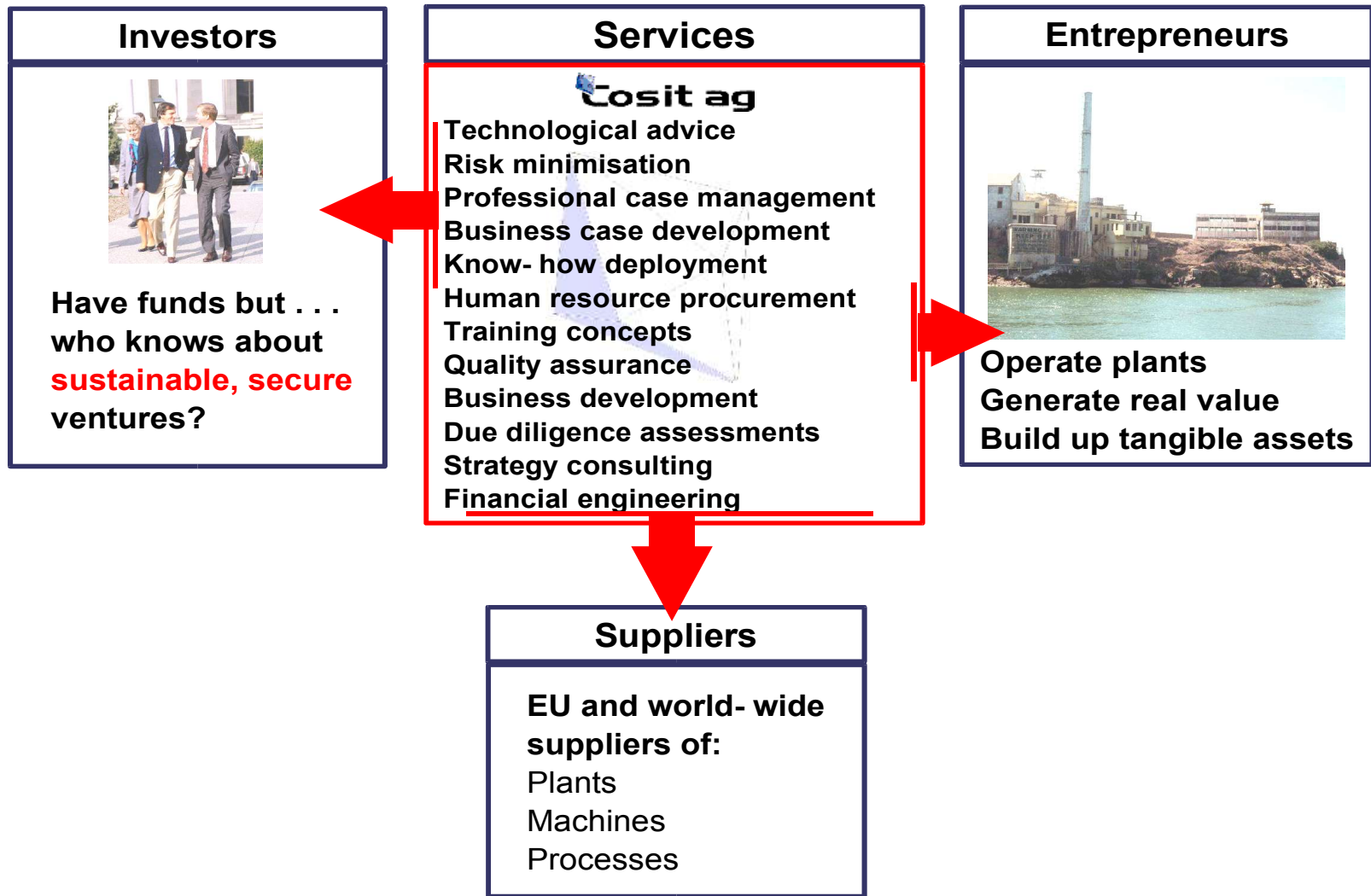

 - IS can be a key success factor



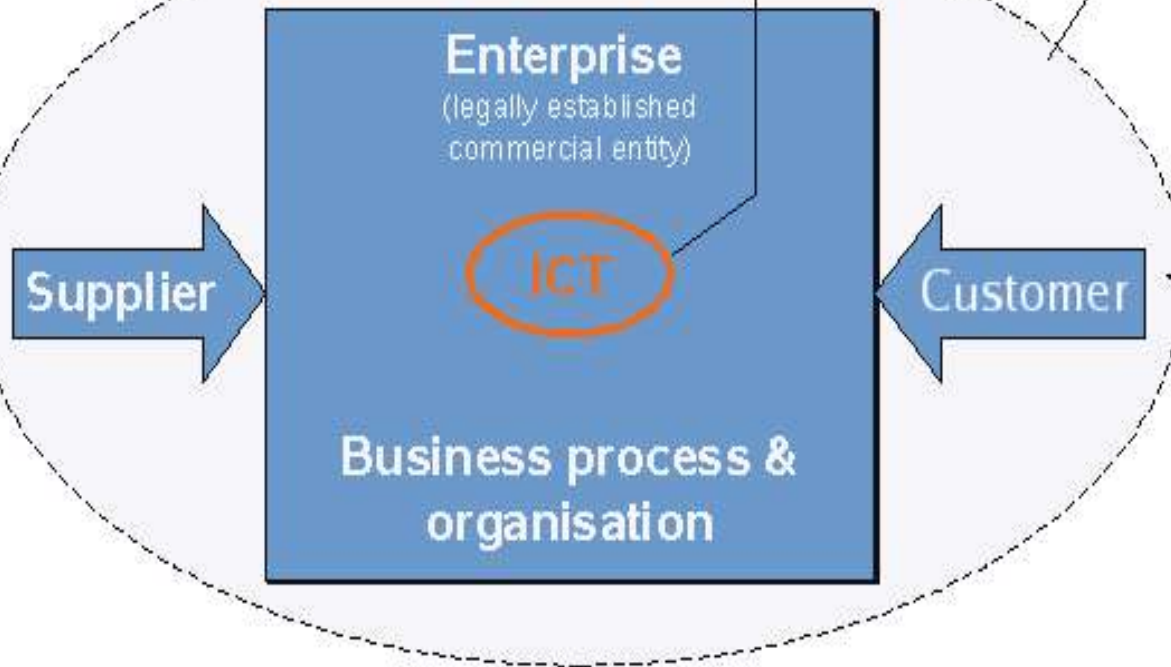

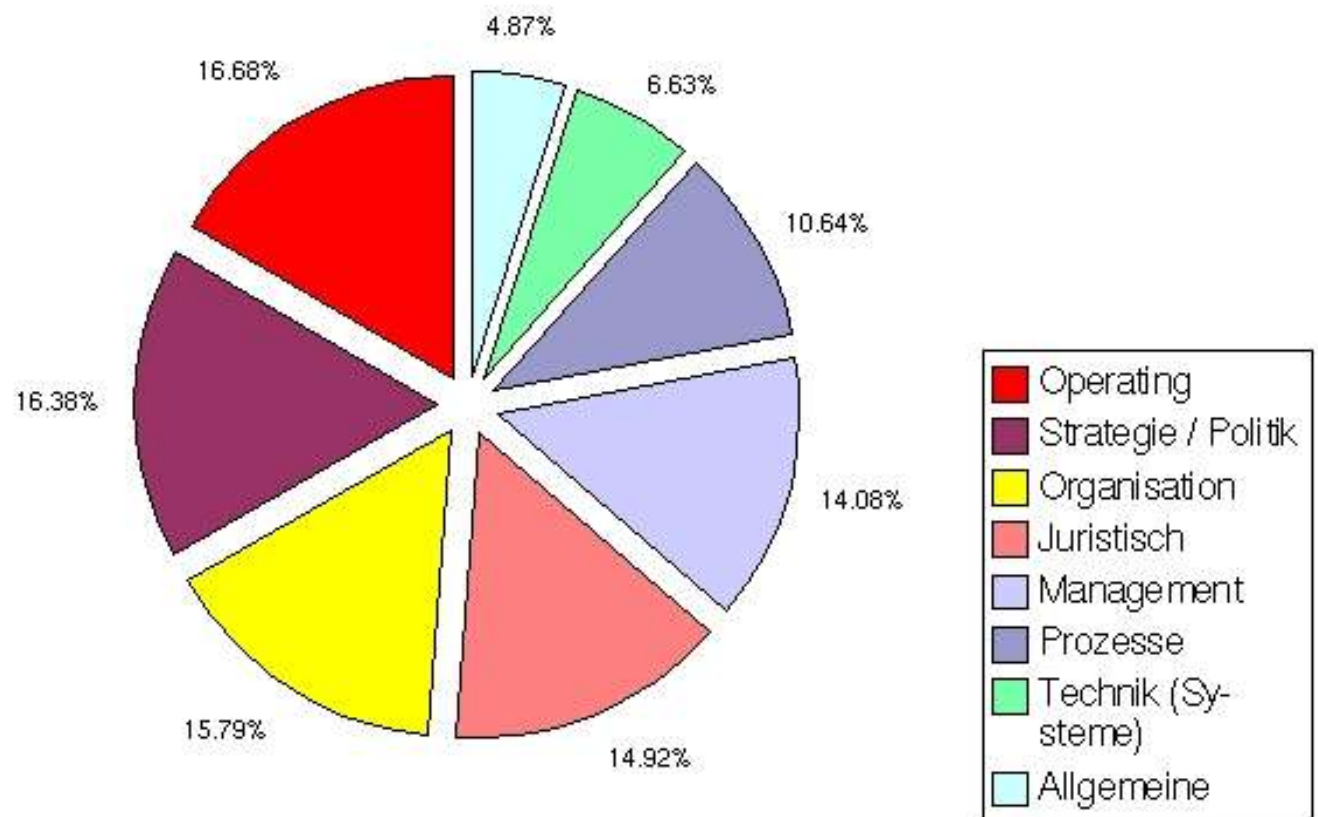
Information Security vs. IT-Security



- IT-security secures your Information Technology (hardware, software and data)
- Information Security secures your information (sensitive data, business processes, personnel)
- Information Security can reduce your risk-level and optimise your business processes

- What are the main effects of a poor Information Security?
 - Penetration
 - Espionage
 - Loss of money
 - Loss of international connections
 - Loss of reputation



Information Security for Banks

- International Standards and recommendations are the key to successful future banking like:
 - Basel II / ISO 17799 / CobiT / . . .
- IS can reduce inefficiencies remarkably
- IS allows a reduction of reserves
- IS is mandatory for growth of the business
- **Banks without IS will loose business and international connectivity**

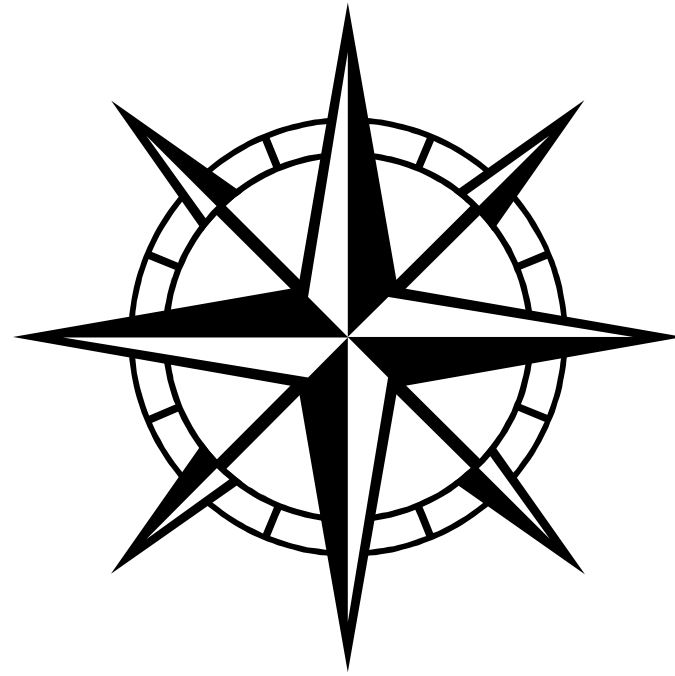
How can Cosit help?
